RESOLUTION

WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, Limited Request for Proposal #2211 was called for by publication for Architectural/Engineering Design Services Correctional Division Projects for the Lake County Adult Correctional Division; and

WHEREAS, sealed proposals were received and opened from eleven (11) vendors in the County Building, Waukegan, Illinois, Thursday, March 28, 2002, at 2:00 p.m.;

WHEREAS, RQAW Consulting Engineers & Architects is familiar with the work to be performed under this contract and Lake County is pleased with their prior performance on similar work; and

WHEREAS, in accordance with the Evaluation Criteria as established in the Request for Proposals, the Selection Review Committee has determined that the proposal submitted by RQAW Consulting Engineers & Architects, Inc is the most favorable proposal for Lake County;

WHEREAS, the jail expansion plan has been modified to relocate Work Release inmates to a newly constructed Tower adjacent to the existing facility to enable the renovation project to proceed and desires to amend the prior resolution to authorize RQAW to perform design services necessary for the complete project scope; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Director of Central Services is hereby directed to enter into a contract with RQAW Consulting Engineers & Architects, Indianapolis, IN in the amount not to exceed \$619,700 for Architectural/Engineering Design Services Correctional Division Projects for Lake County Adult Corrections Division, charging the costs thereof to account #705-705-7051-7030, respectively, and request its adoption.
