



WE RECOMMEND adoption of this Resolution.



RESOLUTION

WHEREAS, pursuant to authority granted by this Board of Lake County, the County Engineer heretofore called for sealed bids by publication for the cleaning and painting of the pedestrian bridge over Lewis Avenue (*County Highway 27*) and situated in the vicinity of Salem Avenue in the City of Zion and designated as Section 03-00089-06-BR; and

WHEREAS, pursuant to said publication calling for said bids, a sealed bid was received and opened on July 29, 2003, at 11:00 a.m., at the Lake County Division of Transportation in Libertyville, Illinois, said bid being as follows:

Eagle Painting and Maintenance Co. Lansing, Illinois..... \$58,000.00

WHEREAS, the Public Works and Transportation Committee, the County Engineer, and the Purchasing Director have examined this bid, and it appears that the sole responsible bidder is Eagle Painting and Maintenance Co., Lansing, Illinois, their bid being \$58,000.00 based on estimated quantities and unit prices; and

WHEREAS, this County Board of Lake County, Illinois, by prior resolution at its meeting of May 13, 2003, appropriated \$150,000.00 of Matching Tax funds for the improvement of the aforesaid section.

NOW, THEREFORE BE IT RESOLVED BY this County Board of Lake County, Illinois, that a contract be awarded to said, Eagle Painting and Maintenance Co., Lansing, Illinois, in accordance with their bid of \$58,000.00 based on estimated quantities and unit prices and that the Purchasing Director, the County Clerk and the County Engineer of Lake County be authorized, and they are hereby directed, to enter into a contract with said bidder for the cleaning and painting of the pedestrian bridge over Lewis Avenue and situated in the vicinity of Salem Avenue in the City of Zion and designated as Section 03-00089-06-BR.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time these quantities may be added to, deducted from or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action provided the final cost chargeable under the funds appropriated does not exceed the appropriation.
