RESOLUTION

WHEREAS, in accordance with Section 3-101 of the Lake County Purchasing Ordinance, bids were called for by publication for Replacement of Overhead Doors in Building "D" for Lake County Division of Transportation; and

WHEREAS, subsequent to said publication, invitations for bids were extended to seventeen (17) vendors; and

WHEREAS, sealed bids were received from seven (7) vendors and opened in the County Building, Waukegan, Illinois on Wednesday, July 30, 2003 at 2:00 p.m.; and

WHEREAS, A Premier Door Corp, Waukegan, IL is the lowest responsive and responsible bidder, and whereas other bids were received from Meadows Door, Carpentersville, IL, \$52,000; Raynor Door Authority of Rockford, Loves Park, IL, \$52,384; Builders Chicago Corporation, Chicago, IL, \$54,877; Pro-Line Door Systems, Wood Dale, IL, 57,650; Industrial Door, Elk Grove Village, IL, \$80,270; American Overhead Door, Schaumburg, IL, \$89,489;

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Director of Central Services is hereby directed to enter into contract with A Premier Door, Waukegan, IL, in the amount of \$49,730.00 for Replacement of Overhead Doors in Building "D" for the Lake County Division of Transportation, charging the costs thereof to account #223-223-0500-8030.
