WHEREAS, in accordance with the Rules of this County Board, bids were called for by publication for the Water Reclamation Facility Expansion and Improvement Project; and

WHEREAS, subsequent to said publication, invitations to bid were extended to ten (10) general contractors; and

WHEREAS, sealed bids were received and publicly opened in the office of the Public Works Department on Tuesday, July 15, 2003, at 2:00 p.m. as follows:
