


WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, Request for Proposal #2327 was called for by publication for Architectural/ Engineering Services for Facilities Assessments for Lake County Facilities; and

WHEREAS, sealed proposals were received and opened from twenty-four (24) vendors in the County Building, Waukegan, Illinois, Thursday, January 22, 2004, at 2:00 p.m.;

WHEREAS, the Selection Review Committee held interviews with the top four (4) ranked firms; and

WHEREAS, in accordance with the Evaluation Criteria as established in the Request for Proposals and the interview, the Selection Review Committee has determined that the proposal submitted by 3D/International, Inc. is the most favorable proposal for Lake County;
