

LAKE COUNTY BOARD PROCEEDINGS**TUESDAY, APRIL 13, 2004**

The Lake County Board met in the Regular September, A.D. 2003 Session of the County Board held on Tuesday, April 13, 2004 in the County Building in Waukegan, Illinois. Member Paxton moved, seconded by Member Gravenhorst to approve the Resolution. The Chair asked for leave of the previous Roll Call. Leave was granted. Motion carried with the following vote: Ayes 22, Nays 0.

Emergency Appropriation – Transfer Between Account Classes – Multi-Jurisdictional Drug Prosecution Grant

Member Paxton moved, seconded by Member Nixon to approve the Resolution. The Chair asked for leave of the previous Roll Call. Leave was granted. Motion carried with the following vote: Ayes 22, Nays 0.

Member Paxton moved, seconded by Member Carlson to approve the Resolution. The Chair called for a Voice Vote on the motion. Motion carried unanimously.

Temporary Easement Agreements – Village of Libertyville – Proposed Dredging Project for Butler Lake and Use of County Farm Property

54. Resolution approving Temporary Easement Agreements with the Village of Libertyville for the use of the County Farm property and under Winchester Road as part of the proposed dredging project for Butler Lake, and authorizing the County Board Chairman to execute said document.

Member Paxton moved, seconded by Member Calabresa to approve the Resolution. The Chair called for a Voice Vote on the motion. Motion carried with Members Newton, Carter and Mounstier voting Nay.

TAXATION, ELECTION AND RECORDS COMMITTEE

Member Talbett noted the County Clerk provided the TER committee an overview of the March 16 primary noting the County's first provisional ballot process and the additional work incidental. She also explained the need for additional M-100 optical scan units to serve precincts to be split due to growth and to better serve where there are currently three precincts on one machine. This is estimated to cost \$312,000. Member Talbett also noted that there were a lot of complaints about the new electioneering law passed by the State permitting campaign workers to come into polling places and on to school property. It was suggested that the committee authorize a letter to our elected State Representatives expressing our concern. Member Martini suggested that the County go on record with state legislators to review this law.

HEALTH AND HUMAN SERVICES COMMITTEE

55. Board of Health Report.

Member Cole moved, seconded by Member Carlson to place the item on the floor. The Chair called for a Voice Vote on the motion. Motion carried unanimously.

Member Spielman referred to the article in the newspapers about TB Clinics. An update from Bill Mays of the Health Department about where we are in Lake County included a report of 30 active cases of TB and we are not experiencing a dramatic increase at this time. The cases tend to be from people who are migrating. About 11% of the skin tests turn out to be positive.

Member Carter noted that regarding the Wauconda well contamination, a joint committee meeting with the USEPA, IEPA, the Lake County Health Department and the Village will be held in May to discuss test results and recommendations.

Member Cole noted that a Resolution on hospital closings and the needs in northwestern Lake County would be coming to the Board in May.

COMMUNITY AND ECONOMIC DEVELOPMENT COMMITTEE

56. Lake County Partners Report.

Member Sabonjian moved, seconded by Member Cunningham to place the item on the floor. The Chair called for a Voice Vote on the motion. Motion carried unanimously.

Member Mountsier gave an update of the Team Lake County meeting and advised that the meeting will be held quarterly. He noted that over 100 people attended this session, and members of industry, retail, real estate, banking, education, all levels of government were represented. He felt the meeting was very successful.

Support Continued Certification of Lake County, Illinois Convention and Visitor's Bureau

57. Resolution supporting the continued certification of the Lake County, Illinois Convention and Visitor's Bureau by the State of Illinois as the bureau designated by the County of Lake to provide visitor referral services for individuals, corporations, and other groups.

Member Sabonjian moved, seconded by Member Stolman to approve the Resolution. The Chair called for a Voice Vote on the motion. Motion carried unanimously.

Member Sabonjian noted that Affordable Housing hearings will be held on May 21 and May 28. He will report back to the County Board on the hearings.

LAW AND JUDICIAL COMMITTEE

Intergovernmental Agreement – Fox Waterway Agency – Provide Sheriff's Marine Patrol Services

58. Joint Resolution authorizing the Chair of the Board and the Sheriff to execute an intergovernmental agreement with the Fox Waterway Agency (FWA) for the purpose of providing Sheriff's Marine Patrol Services for the Agency.

Member Nixon moved, seconded by Member Mountsier to approve the Joint Resolution. The Chair called for a Voice Vote on the motion. Motion carried with Member Cole voting Nay.

LEGISLATIVE AND INTERGOVERNMENTAL AFFAIRS COMMITTEE

Member Spielman reported on the status of all bills at the state level and noted that they are monitoring closely SB 1498 which is now HB 850 "7% Solution." At the Federal level, all bills are in and thanks to our Senators and Congressman for funding for the intelligent

transportation center. Groundbreaking for the traffic control center in Libertyville will be this spring and target date for opening will be somewhere between June 8 and July 4.

PUBLIC WORKS AND TRANSPORTATION COMMITTEE

Items 59 and 60

Member O'Kelly moved, seconded by Member Maine to approve Items 59 and 60 in one Voice Vote. The Chair called for a Voice Vote on the motion. Motion carried unanimously.

Contract – Aldridge Electric, Inc. – Traffic Signal Interconnect Along Aptakisic Road

59. Joint Resolution awarding a contract for the traffic signal interconnect along Aptakisic Road (County Highway 33) from IL Rt. 21 to Buffalo Grove Road (County Highway 16) to the lowest responsible bidder, Aldridge Electric, Inc., Libertyville, Illinois, in the amount of \$888,750.91.

Resurface Deerfield Road From IL Rt. 21 to Saunders Road

Member Martini moved, seconded by Member Newton to approve the Resolution. The Chair called for a Voice Vote on the motion. Motion carried unanimously. Member Martini noted that the PB&Z committee had met this morning to review recommendations of the Public Works and Transportation Committee regarding this Chapter. Questions were raised and Member Sabonjian moved, seconded by Member Cole to reconsider the Resolution. Member

Martini moved, seconded by Member Mountsier to amend the airport and harbor text on Pages 7-16 and 7-17 as outlined in the handout. The Chair called for a Voice Vote on the motion. Motion carried unanimously. Member Newton stated that she had concerns about this but would vote for it so that we start the hearings. Member Martini moved, seconded by Member Newton to approve the item as amended. The Chair called for a Voice Vote on the motion. Motion carried unanimously.
