RESOLUTION

WHEREAS, an intergovernmental agreement currently exists between Lake County and the Village of Long Grove for the provision of additional Sheriff's patrol exclusive to the Village of Long Grove for eight hours per day; and

WHEREAS, this agreement calls for exclusive police patrol in Long Grove by one (1) Deputy eight (8) hours per day; and

WHEREAS, the agreement allows for once per year mutually agreed upon rate adjustments; and

WHEREAS, the current rate for this service is \$14,506.73 per month; and

WHEREAS, the County and the Village are proposing the new rate for the service will be \$15,232.07 per month.; and

WHEREAS, this rate is subject to change again on January 1, 2005, to a rate mutually agreed by both parties.

NOW, THEREFORE, BE IT RESOLVED by this County Board of Lake County, Illinois, that the Chair of the Board and the Sheriff are hereby authorized increase the rate charged to the Village of Long Grove for exclusive police service in the Village from \$14,506.73 per month to \$15,232.07 per month, effective June 1, 2004.
