, a distance of approximately 1.4 mi.; and,

BE IT FURTHER RESOLVED, that the type of improvement shall be bituminous resurfacing

and shall be designated as Section 03-00143-09-RS ^{-MFT}_{-CF;} and,

BE IT FURTHER RESOLVED, that the improvement shall be constructed by contract

BE IT FURTHER RESOLVED, that there is hereby appropriated the sum of Five Hundred

and Sixty Thousand Dollars, (\$560,000.00)

from the County's allotment of Motor Fuel Tax funds for the construction of this improvement; and,

BE IT FURTHER RESOLVED, that the Clerk is hereby directed to transmit two certified copies of this resolution to the district office of the Department of Transportation.
