RESOLUTION

WHEREAS, on August 12, 2003, pursuant to Resolution and Ordinance heretofore passed and approved, proceeds in the amount of \$14,723,794.07 were received by Robert Skidmore, Treasurer of Lake County, Illinois; \$263,794.07 was set aside for the debt service reserve fund and accrued interest and \$14,460,000.00 was placed in the Series B & C of 2003 Construction Account to pay for the cost of constructing the Vernon Hills – NCT Water Reclamation Facility Improvements; and

WHEREAS, Section 502, Article V of the Bond Ordinance passed by the Board of Supervisors of Lake County on October 13, 1964, and amended on June 10, 1968, requires the approval of the County Board for disbursements from the Construction Account.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that Robert Skidmore, Treasurer of Lake County, Illinois, be and he is hereby authorized and directed to withdraw monies from the Series B & C of 2003 Construction Account to pay the following construction cost items:
