## RESOLUTION

WHEREAS, in accordance with Section 4-102 of the Lake County, Purchasing Ordinance, bids were called for by publication for the installation of an automatic fire protection sprinkler system for Lake County Winchester House; and

WHEREAS, subsequent to said publication, invitations for bids were extended to twenty-five (25) vendors; and

WHEREAS, sealed bids were received from four (4) vendors and opened in the County Building, Waukegan, Illinois, on Wednesday, May 19, 2004, at 2:00 p.m.; and

WHEREAS, Petra Contracting, Inc., Lombard, IL, is the lowest responsive and responsible bidder in the amount of \$1,295,200, other responsive bids were received from: Rasch Construction, Kenosha, WI - \$1,728,000; United States Fire Protection, Lake Forest, IL - \$2,156,000; Camosy Incorporated, Waukegan, IL - \$2,520,000; and

WHEREAS, Petra Contracting Inc. has extended their bid to Lake County through March 11, 2005;

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Director of Central Services is hereby directed to enter into a contract with Petra Contracting, Inc., Lombard, Illinois, in the base bid amount of \$1,295,200 for the installation of an automatic fire protection sprinkler system for Lake County Winchester House, charging the costs thereof to account #101-1103170-82020-000-000-000-00000
