AN ORDINANCE authorizing and providing for the issuance of not to exceed \$3,500,000 General Obligation Refunding Bonds, Series 2005 (Sales Tax Alternate Revenue Source), of The County of Lake, Illinois, for the purpose of refunding certain outstanding alternate bonds of the County, prescribing all the details of said Series 2005 bonds and providing for the imposition of taxes to pay the same, and for the collection, segregation and distribution of certain sales taxes received by the County; further authorizing and providing for the execution of an escrow agreement in connection with the issue of said Series 2005 bonds.
