RESOLUTION

WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, Request for Proposal #24183 were called for by publication for Cafeteria, Vending and Commissary Services; and

WHEREAS, requests for proposals were sent to seventy (70) vendors and proposals were received and opened from four (4) vendors in the County Building, Waukegan, Illinois on Tuesday, October 19, 2004, at 2:00 p.m. and

WHEREAS, the Selection Review Committee interviewed the four (4) proposers and found one (1) proposal to be non-responsive; and

WHEREAS, in accordance with the Evaluation Criteria as established in the Request for Proposals and the interview, the Selection Review Committee has determined that the proposal submitted by Aramark is the most favorable proposal for Lake County;

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Director of Central Services is hereby directed to enter into a contract with Aramark, Oak Brook, IL, for Cafeteria, Vending and Commissary Services and to pay commissions to Lake County as follows: minimum of \$35,000 or twelve and one half (12.5) percent of gross sales, whichever is greater, for Vending Services; minimum of twenty (20) percent of gross sales for Commissary Services; and minimum commissions increasing annually from one (1) percent to five (5) percent for Cafeteria Services
