WHEREAS, in accordance with Section 4-102 of the Lake County Purchasing Ordinance bids were called for by publication for Painting in the Lake County Courthouse Complex and other Lake County Facilities and for painting projects as required by Lake County; and

WHEREAS, subsequent to said publication, invitations for bids were extended to twelve (12) vendors; and

WHEREAS, sealed bids were received from five (5) vendors and opened in the County Building, Waukegan, Illinois on Thursday, August 25, 2005, at 2:00 p.m.; and

WHEREAS, Prime Coat Coating Systems, is the lowest responsive and responsible bidder for the Painting in the Lake County Courthouse Complex in the amount of \$37,014.12, other responsible bids were received from: Stried Painting, Inc., Grayslake, IL - \$39,110; International Decorators, Inc., Barrington, IL - \$93,163.00; Ruffalo Painting Company, Inc. Kenosha, WI - \$190,566.00, one (1) non-responsive bid from the following: Apex Painting and Decorating Inc.; and

WHEREAS, awards will also be made to the subsequent lowest responsive and responsible bidders for various painting projects throughout Lake County: Stried Painting, Inc., Grayslake, IL; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Director of Central Services is hereby directed to enter into contract for the Painting in Lake County Courthouse Complex with Prime Coat Coating Systems, in the amount of \$37,047.12 and for future painting projects as required for a one year contract, plus renewal options, with Prime Coat Coating Systems, Libertyville, IL; and Stried Painting, Inc., Grayslake, IL charging the costs thereof to account #101-1220010-82020-000-000-00000 and future painting projects as required to various accounts.
