WHEREAS, Lake County established Kid's Korner to provide parents or guardians a safe location to leave their children while they are attending a court hearing as a litigant, witness or other court purposes; and

WHEREAS, pursuant to state statute, specifically 705 ILCS 105/27.704, which states that a County Board may establish a Children's Waiting Room Fee to be collected by the Clerk of the Circuit Court from litigants in civil cases; and

WHEREAS, said fee is not to exceed \$5.00, and

WHEREAS, Court Administration and County Administration recommend that the current Children's Waiting Room Fee charged to litigants in civil cases be increased from \$4.00 to \$5.00 effective December 1, 2005.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Children's Waiting Room Fee charged to litigants in civil cases shall be increased from \$4.00 to \$5.00, effective December 1, 2005.
