RESOLUTION

WHEREAS, the State's Attorney's Office has identified a need for a part-time investigator to assist with investigations involving economic crime, identify theft, trading and selling of child pornography, child abuse, and sophisticated drug conspiracies; and

WHEREAS, offsetting revenue is available from the State's Attorney's Computer Fraud Forfeiture Fund; and

WHEREAS, the creation of this positions necessitates an emergency appropriation of \$20,000 to provide for the costs of said position for the remaining pay periods of FY05; and

WHEREAS, offsetting revenue in the amount of \$ 20,000 shall be deposited in account 101-3300010-45400.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois that a part-time Principal Investigator position be added to the Lake County State's Attorney's Office; and

BE IT FURTHER RESOLVED, that an emergency appropriation of \$20,000 is hereby authorized; and

BE IT FURTHER RESOLVED, that if funding for the position from the Computer Fraud Forfeiture Fund becomes unavailable the position shall be removed from the State's Attorney's Office.
