WHEREAS, the Lake County Sheriff's Department has received \$36,742 in grant funds from the Illinois Criminal Justice Information Authority on behalf of the Metropolitan Enforcement Group; and

WHEREAS, it is necessary that the County Board authorize an emergency appropriation in the amount of \$36,742 to permit the expenditure of the grant funds.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois that an increase in the Corporate Fund revenue budget to account number 101-3003130-45350-000-000-000-00000 is authorized in the amount of \$36,742 in state funding in connection with the Metropolitan Enforcement Group grant; and

BE IT FURTHER RESOLVED, that an emergency appropriation in the Corporate Fund in the amount of \$36,742 is authorized in account number 101-3003130-79950-000-000-000-00000.
