**BE IT RESOLVED**, by the County Board of Lake County, Illinois that the following described County Highway(s) be improved under the Illinois Highway Code:

County Highway(s) 11 (Deerfield Rd.), beginning at a point near Saunders Road

and extending along said route(s) in a (n) E. direction to a point near Wilmot Road

, a distance of approximately 1.2 mi.; and,

**BE IT FURTHER RESOLVED**, that the type of improvement shall be construction of a bike path along Deerfield Road and including a tunnel beneath the access ramp to Interstate 94

and shall be designated as Section 02-00034-01-BT <sup>-MT</sup> and,

**BE IT FURTHER RESOLVED**, that the improvement shall be constructed by contract

and by the county through its officers, agents, and employees; and

**BE IT FURTHER RESOLVED**, that there is hereby appropriated the sum of \$2,380,000.00 TWO MILLION THREE HUNDRED EIGHTY THOUSAND and .00/100 dollars, (\$2,380,000.00)

From the County's allotment of Motor Fuel Tax funds for the construction of this improvement.
