






RESOLUTION

WHEREAS, the County Administrator has undertaken a review of the organizational structure of the Office of Management and Budget and the Central Services Department; and

WHEREAS, as a result of this review, the County Administrator has developed a recommendation to realign the responsibilities of the Office of Management and Budget and the Central Services Department to more effectively address operational needs; and

WHEREAS, the Financial and Administrative Committee at its September 6, 2006 meeting authorized the attached Table of Organization that combines the Office of Management and Budget and the Central Services Department; and

WHEREAS, as a result of the reorganization the County Administrator recommended the reclassification of the Director of the Office of Management and Budget (pay grade 20) to the Director of Administrative and Financial Services (pay grade 21), Assistant County Administrator (pay grade 17) to the Budget Manager (pay grade 17), Assistant Director of Central Services (pay grade 16) to the Purchasing Agent (pay grade 17) ; and

WHEREAS, as a result of the reorganization the County Administrator recommended that the position of Director of Central Services be eliminated and replaced by the Director of Administrative and Financial Services; and

WHEREAS, as a result of the reorganization the County Administrator recommended that two new positions be created, Contract Administrator (pay grade 14) and Research Analyst (pay grade 12); and

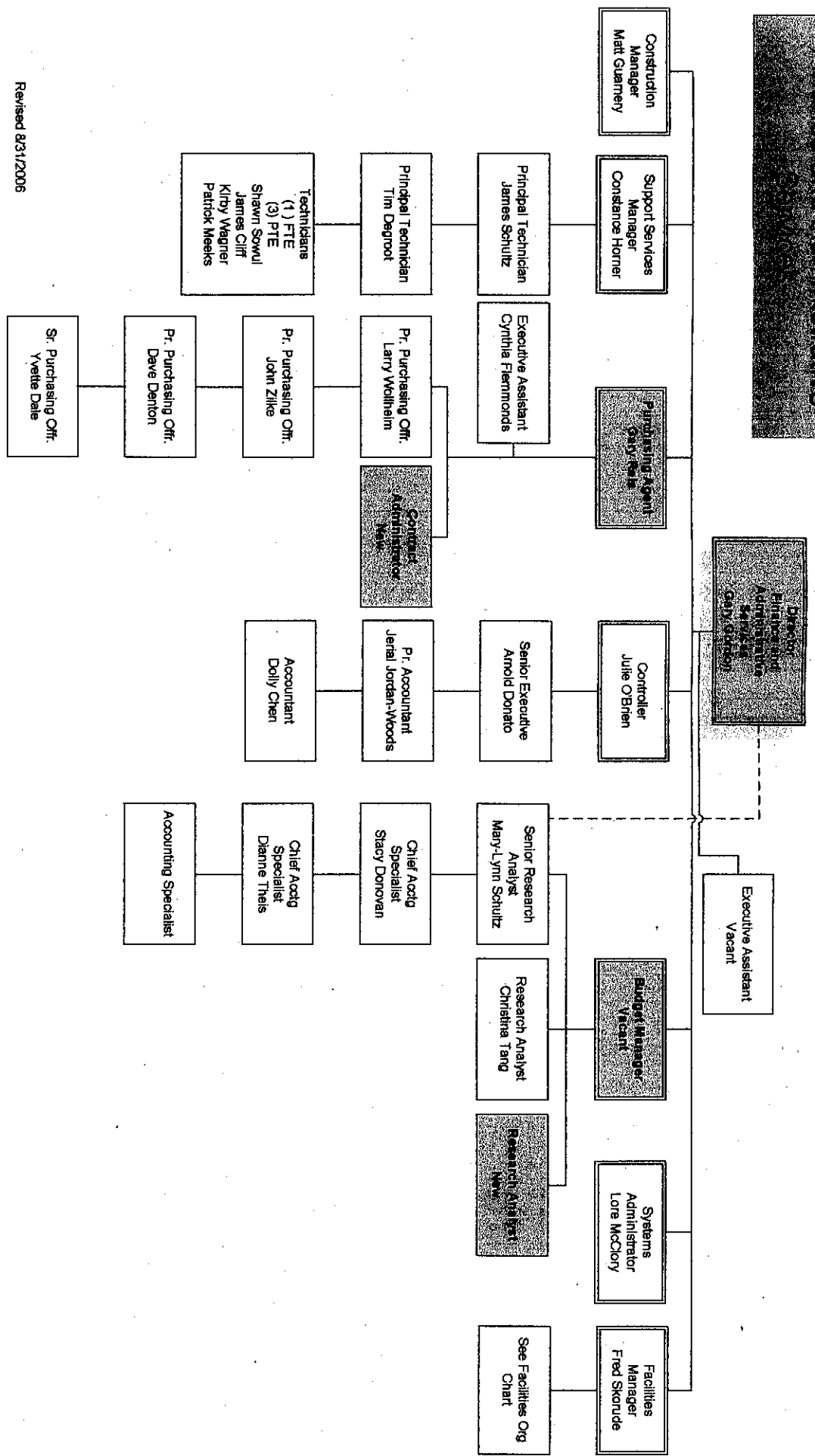
WHEREAS, this reorganization will not result in an increase in annual expenditure for wages; and

WHEREAS, County Board approval is required to authorize the new Table of Organization combining the Office of Management and Budget and the Central Services Department into the Department of Administrative and Financial Services.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that Table of Organization be approved creating the Department of Administrative and Financial Services.
