WHEREAS, the Lake County Board awarded a contract for Chiller Maintenance for 18 N. County and Winchester House to Carrier Corporation, Elmhurst, IL on December 14, 2005; and

WHEREAS, that contract provided for Carrier Corporation to perform Chiller Repair as required based on bid contract unit prices; and

WHEREAS, there is a need to repair the #2 Chiller at 18 N. County and the #1 and #2 Chillers at Winchester House, and a need to perform a major compression inspection for Chillers #1 and #2 at the Babcox Center; and

WHEREAS, Carrier Corporation has submitted a proposal to do this work based on bid contract unit prices; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to award a contract for Chiller Repair for 18 N. County and Winchester House, and Compression Inspection at the Babcox Center with Carrier Corporation, in an amount estimated not to exceed \$151,929.00 charging the costs thereof to 101-1103285-82020-000-000-00000 and request its adoption.
