RESOLUTION

WHEREAS, Hutchins Road, north of Stearns School Road and Stearns School Road (*County Highway 74*) are designated routes on the County Highway System; and

WHEREAS, this County Board of Lake County, Illinois, by prior resolution at its meeting of May 9, 2006 added Hutchins Road from IL Rte. 132 to Stearns School Road as a designated highway to the county highway system; and

WHEREAS, the Village of Gurnee and Lake County are desirous of entering into an agreement for the jurisdictional transfer from the Village of Gurnee to Lake County of that section of Hutchins Road from the northerly municipal limits of the Village of Gurnee southerly to IL Rte. 132, a distance of approximately 616 feet; and

WHEREAS, a draft copy of said agreement between the Village of Gurnee and the County is attached hereto entitled as Local Agency Agreement for Jurisdictional Transfer.

NOW, THEREFORE BE IT RESOLVED, by this County Board of Lake County that the Chair of the County Board, the County Clerk and County Engineer of Lake County are authorized and are hereby directed to execute the Local Agency Agreement for Jurisdictional Transfer for the jurisdictional transfer from the Village of Gurnee to Lake County for that piece of Hutchins Road from the northerly municipal limits of the Village of Gurnee southerly to IL Rte. 132. The County Engineer shall transmit in writing the final Local Agency Agreement for Jurisdictional Transfer to be executed by the Chair of the Lake County Board and the County Clerk.

BE IT RESOLVED that this Local Agency Agreement for Jurisdictional Transfer Agreement, when executed in its final form, be submitted to Illinois Department of Transportation for their approval and final processing.
