**RESOLUTION**

**WHEREAS**, certain segments of the population, including the elderly persons with disabilities and persons with medical needs, require door-to-door (or curb-to-curb) transportation services that are demand-responsive, hereafter referred to as paratransit services; and

**WHEREAS**, numerous social service agencies and local governments provide paratransit services; and

**WHEREAS**, existing paratransit services often limit rider eligibility or geographic destinations abased on various funding sources, making it difficult for individuals to obtain the transportation services they need; and

**WHEREAS**, there is a significant unmet travel need among seniors and persons with disabilities or medical needs, an unmet need that is projected to increase substantially during the next 20 years; and

**WHEREAS**, the Lake County Coordinated Transportation Services Committee is a broad coalition of government officials, service providers and advocacy groups concerned with the coordination of paratransit services; and

**WHEREAS**, the Lake County Coordinated Transportation Services Committee's vision is to develop the first borderless paratransit system in Lake County to meet the needs of seniors and person with disabilities or medical needs.

**NOW, THEREFORE, BE IT RESOLVED**, that Lake County, recognized the unmet travel needs of seniors and persons with disabilities or medical needs and supports the local agencies of Lake County in their initiative with the Lake County Coordinated Transportation Services Committee in its efforts to enhance paratransit services to the citizens of all communities located within Lake County.
