WHEREAS, sealed bids were received from nine (9) vendors and opened in the County Building, Waukegan, Illinois on Wednesday, November 7, 2007, at 2:00 p.m.; and

WHEREAS, Driessen Construction Co., St. Charles, IL is the lowest responsive and responsible bidder for Replacement of Interior Doors and Installation of Acoustical Wall Panels in the Courts Complex in the amount of \$146,700.00 and other bids were received from: Success Ventures, Chicago IL - \$133,268.00 (Non-Compliant); Car-Min Construction, Waukegan, IL - \$156,670.00; Camosy, Inc., Waukegan, IL - \$157,582.00, Madison Construction, Orland Park, IL - \$167,131.00; Happ Builders, Waukegan IL - \$170,800.00; Terra Development & Services., Libertyville, IL - \$181,310.00; Stuckey Construction Co., Waukegan, IL - \$192,600.00 and Boller Construction Co., Waukegan, IL - \$200,950.00.
