WHEREAS, sealed proposals were received from two (2) firms and opened in the County Building, Waukegan, IL on Friday, November 2, 2007 at 2:00 p.m.; and

WHEREAS, based on the criteria set forth in the Request for Proposals, an Evaluation Committee comprised of representatives from the 19th Judicial Circuit Court, States Attorney, Public Defender and Information Technology reviewed both proposals received; and

WHEREAS, in accordance with the Evaluation Criteria as established in the Request for Proposal and the interview, the Evaluation Committee has determined that the proposal submitted by WestLaw Thomson West is the most favorable proposal for Lake County.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into a contract with WestLaw Thomson West of Egan, MN for the Internet Based Legal Research Subscription Service for Lake County for a two(2) year period plus renewals in the estimated amount \$529,332.00 charging the total cost to various Lake County accounts and requests its adoption.
