WHEREAS, in accordance with Section 5-101 of the Lake County Purchasing Ordinance, Request for Proposals were called for by publication for Federal Representation Services for Lake County; and

WHEREAS, subsequent to said publication, a Request for Proposal was extended; and

WHEREAS, sealed proposals were received from three (3) firms and opened in the County Building, Waukegan, IL on Tuesday, November 6, 2007 at 2:00 p.m.; and

WHEREAS, based on the criteria set forth in the Request for Proposal, an Evaluation Committee comprised of representatives from the County Administrator's Office, the Lake County Board, Stormwater Management and Purchasing reviewed all proposals received; and

WHEREAS, interviews were conducted with each respondent; and

WHEREAS, in accordance with the Evaluation Criteria as established in the Request for Proposal and the interview process, the Committee has determined that the proposal submitted by The Ferguson Group LLC is the most favorable proposal for Lake County.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into a contract with The Ferguson Group LLC of Washington D.C., for Federal Representation Services for Lake County for a two year period plus renewals in the estimated amount of \$99,996.96 charging the total cost to account number 101-1102040-79950-000-000-000000 and requests its adoption.
