RESOLUTION

WHEREAS, Illinois law authorizes the Sheriff to charge fees for specified services conducted by said department; and

WHEREAS, the Illinois General Assembly passed and the Governor signed into law 55 ILCS 5/4-5001; and

WHEREAS, 55 ILCS 5/4-5001 provides for the increase of the fees charged by the Sheriff if the County can demonstrate that said statutory fees are inadequate; and

WHEREAS, the County in 2004 commissioned Miller, Cooper and Company to provide a fee study using 2003 financial data of the full cost of providing County services provided by the Sheriff's Office; and

WHEREAS, the results of said fee analysis combined with additional review showed fees being charged by the Sheriff are not reflective of the full cost of providing those services; and

WHEREAS, the fees have remained unchanged since November 10, 1992; and

WHEREAS, it is in the best interest of the citizens of Lake County that the cost of performing a specific service should be reflective of the fee charged for that service.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Chair of the Board and the Sheriff are hereby authorized to execute the following fees:
