MADAM CHAIR AND MEMBERS OF THE COUNTY BOARD:

A joint resolution awarding (2) two contracts: 1) for the widening and resurfacing of the intersection of Peterson Road (*County Highway 20*) and Midlothian Road (*County Highway 48*) and designated Section 07-00244-01-CH, to the lowest responsible bidder Curran Contracting Company, Crystal Lake, Illinois, in the amount of \$821,964.38; and 2) for the extension of Midlothian Road northerly from Peterson Road and designated as Section 07-00244-01-CH to the lowest responsible bidder Curran Contracting Company, Crystal Lake, Illinois in the amount of \$782,197.60. The aggregate total for these two combined bids is \$1,604,161.98. These two highway improvements are necessary to facilitate for the Lake County Fair in July of 2008.

RESOLUTION

WHEREAS, pursuant to authority granted by this Board of Lake County, the County Engineer heretofore called for sealed bids by publication for two (2) highway Improvement projects to be awarded in combination with one another: 1)) for the widening and resurfacing of the intersection of Peterson Road (*County Highway 20*) and Midlothian Road (*County Highway 48*) and designated Section 07-00244-01-CH; and 2) for the extension of Midlothian Road northerly from Peterson Road and also designated as Section 07-00244-01-CH. These two projects are being awarded in combination with one another in order to facilitate the Lake County Fair in July of 2008; and

WHEREAS, pursuant to said publication calling for said bids, sealed bids were received and opened on January 29, 2008, at 10:00 a.m., at the Lake County Division of Transportation in Libertyville, Illinois, a tabulation of said bids being as follows:

WHEREAS, the Public Works and Transportation Committee, the County Engineer, and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder, in aggregate, for the two projects is Curran Contracting Company, Crystal Lake, Illinois, their bid being \$821,964.38 for the improvements to the intersection of Peterson Road and Midlothian Road, and their bid being \$782,197.60 for the extension of Midlothian Road northerly from Peterson Road, both based on estimated quantities and unit prices; and

WHEREAS, this County Board of Lake County, Illinois, by prior resolution at its meeting of August 14, 2007, appropriated \$2,800,000.00 of Matching Tax funds for both of the aforesaid improvements.

NOW, THEREFORE BE IT RESOLVED BY this County Board of Lake County, Illinois, that contracts be awarded to said Curran Contracting Company, Crystal Lake, Illinois, in accordance with their bid being \$821,964.38 the widening and resurfacing of the intersection of Peterson Road and Midlothian Road and \$782,197.60 for the extension of Midlothian Road, both based on estimated quantities and unit prices and that the Purchasing Agent, the County Clerk and the County Engineer of Lake County be authorized, and they are hereby directed, to enter into contracts with said low bidder for 1) for the widening and resurfacing of the intersection of Peterson Road and Midlothian Road and designated Section 07-00244-01-CH; and 2) for the extension of Midlothian Road northerly from Peterson Road and designated as Section 07-00244-01-Ch. Both contracts being awarded in combination with one another in order to facilitate completion of said projects to provide for the Lake County Fair in July of 2008.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time these quantities may be added to, deducted from or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board

action provided the final cost chargeable under the funds appropriated does not exceed the appropriation.
