WHEREAS, proposals were called for by publication Jail Inmate Kiosk Services for the Lake County Adult Correctional Division to collect, maintain and disburse inmate funds; and

WHEREAS, subsequent to said publication, Request for Proposals were extended to seven (7) potential service providers; and

WHEREAS, sealed proposals were received from three (3) vendors and opened in the County Building, Waukegan, Illinois, on October 30, 2007 at 2:00 p.m.; and

WHEREAS, the Sheriff's Office reviewed each proposal; and

WHEREAS, in accordance with the Evaluation Criteria established in the Request for Proposal, the Sheriff's Office has determined that the proposal submitted by ICS Solutions is the most favorable proposal for Lake County; and

WHEREAS, Lake County will receive a commission of \$1.00 per deposit transaction for approximately 2,200 deposit transactions per month.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, authorizing the Purchasing Agent to enter into a contract with ICS Solutions, 5883 Rue Ferrari, San Jose, Ca to provide Jail Inmate Kiosk Services for the Lake County Adult Correctional Division, to pay commissions for a five (5) year period and request its adoption.
