WHEREAS, in accordance with Section 5-102 of the Lake County Purchasing Ordinance, proposals were called for by publication an Integrated Public Defender Case Management System for Lake County; and

WHEREAS, subsequent to said publication, request for proposals were extended to eighteen (18) vendors; and

WHEREAS, sealed proposals were received from seven (7) vendors and opened in the County Building, Waukegan, Illinois, on October 25, 2007 at 2:00 p.m.; and

WHEREAS, based on the criteria set forth in the Request for Proposals, an Evaluation Committee comprised of representatives from the Public Defender's Office and Information and Technology Department reviewed each proposal and held interviews with the top two (2) ranked firms; and

WHEREAS, in accordance with the Evaluation Criteria established in the Request for Proposal and the interview, the Evaluation Committee has determined that the proposal submitted by Software Development and Services Corporation is the most favorable proposal for Lake County; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, authorizing the Purchasing Agent to enter into a contract with Software Development and Services Corporation, Fairfax, VA for an Integrated Public Defender Case Management System for Lake County in an amount not to exceed \$471,408.00, charging the costs thereof to #101-1103160-84040-000-000-000000.
