RESOLUTION

WHEREAS, off-duty "Special Detail" are those assignments established between the Lake County Sheriff's Office and private business, individuals and governmental units within the County of Lake, and which are not part of the normal watch function; and

WHEREAS; effective May 1, 2007 the current rate for special detail patrol is \$73.00 per hour; and

WHEREAS, the Sheriff's Office and the County Administrator's Office have agreed this rate needs to be increased to better recover actual costs; and

WHEREAS, a two-tiered rate system was made effective May 1, 2005 which made a distinction between the rates charged for special detail services in unincorporated portions of Lake County and in those incorporated areas without a Police Department from the rates charged for special detail services in a municipality with a Police Department; and

WHEREAS, the Sheriff's Office and the County Administrator's Office will review these rates annually to assure actual costs are being recovered and can be increased if agreed upon by the Sheriff's Office and the County Administrator's Office.

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that:

1. The hourly rate for special detail patrol within the Sheriff's primary jurisdiction shall be \$78.00 per hour effective May 1, 2008, \$81.00 per hour effective May 1, 2009, \$85.00 per hour effective May 1, 2010 and \$88.00 per hour effective May 1, 2011.
2. The hourly rate for special detail patrol within a municipal police jurisdiction shall be \$93.00 per hour effective May 1, 2008, \$95.00 per hour effective May 1, 2009, \$97.00 per hour effective May 1, 2010 and \$99.00 per hour effective May 1, 2011.
3. The billing and collection of these services will continue to be performed by the Sheriff's Office with all collections deposited into 101-3001110-46290 Special Police Services of the Lake County General Corporate Fund. Deputies will be paid for these details in payroll checks with all applicable deductions.

BE IT FURTHER RESOLVED, that the County Clerk is hereby directed to forward a certified copy of this Resolution to the Lake County Sheriff.
