WHEREAS, in accordance with Section 4-102 of the Purchasing Ordinance of Lake County, Illinois, bids were called for by publication for Printing and Fulfillment Mailing Services for the Lake County News Letter; and

WHEREAS, subsequent to said publication, invitations for bids were extended to twelve (12) vendors; and

WHEREAS, sealed bids were received from seven (7) vendors and opened in the County Building, Waukegan, Illinois on Thursday May 29, 2008, at 2:00 p.m.; and

WHEREAS, Spectra Print Corporation, Stevens Point, WI is the lowest responsive and responsible bidder for the Printing and Fulfillment Mailing Services for the Lake County News Letter, in the amount of \$80,705.00, the other responsible bids received were from: Badger Press, Kenosha, WI (submitted two bids) in the amounts of \$101,429.00 and \$98,954.00; LRD Systems, Woodstock, IL - \$86,771.50 and Performance Graphics, Elmhurst, IL in the amount of \$115,478.75; and

WHEREAS, two non-responsive bids were received from Aspen Printing , Naperville, IL - \$46,901.75 and AB Direct, Miamisburg, OH - \$72,525.00.
