WHEREAS, in accordance with Section 4-102 of the Lake County Purchasing Ordinance, bids were called for by publication for Masonry, Limestone, and Concrete Restoration at the Administration/Courthouse Complex at 18 No. County, Waukegan, IL; and

WHEREAS, invitations for bids were extended to sixteen (16) vendors; and

WHEREAS, sealed bids were received from seven (7) vendors and opened in the County Building, Waukegan, Illinois on Tuesday, June 10, 2008, at 2:00 p.m.; and

WHEREAS, Safe-Way Tuckpointing Co., is the lowest responsive and responsible bidder for Masonry, Limestone and Concrete Restoration at the Courthouse Complex for Lake County in the estimated amount of \$329,921.00, other bids were received from: Able Building Restoration, McHenry, IL - \$571,550.00; Eugene Matthews, Chicago, IL - \$653,750.00; J.S.L. Masonry, Franklin Park, IL - \$949,158.00; Mark 1 Restoration, Dolton, IL - \$1,033,368.00; and

WHEREAS, two non-responsive bids were received from Restore Masonry, Chicago, IL - \$1,323,870.00 and Grove Masonry Maintenance, Alsip, IL - \$1,627,681.75; and

NOW, THEREFORE, BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Purchasing Agent is hereby directed to enter into a contract with Safe-Way Tuckpointing, Des Plaines, IL in the estimated amount of \$329,921.00, for Masonry, Limestone and Concrete Restoration at the Administration/Courthouse Complex for Lake County, charging account 101-1103285-82020-000-000-000-11169 and requests its adoption.
