**NOW, THEREFORE BE IT RESOLVED** by this County Board of Lake County, IL that there is hereby appropriated \$80,000.00 of Matching Tax funds for the construction of said bike path from North Patriot Drive to 200 feet south of Heritage Trail and designated as Section 06-00072-10-BT.
