RESOLUTION

WHEREAS, pursuant to authority granted by this County Board of Lake County, Illinois the County Engineer heretofore called for sealed bids by publications for the Full Depth Bituminous Pavement Patching, where necessary, on various county highways and designated as Section 08-00000-11-GM; and

WHEREAS, pursuant to said publication calling for said bids, sealed bids were received and opened on June 24, 2008, at 10:00 A.M., at the Lake County Division of Transportation in Libertyville, Illinois, a tabulation of said bids being as follows:

WHEREAS, the Public Works and Transportation Committee, the County Engineer, and the Purchasing Agent have examined each bid, and it appears that the lowest responsible bidder is, Greg Greenhill Construction Company, Inc., Ringwood, Illinois, their bid being \$478,576.50 based on estimated quantities and unit prices; and

WHEREAS, this County Board of Lake County, Illinois, by prior resolution at its meeting of May 13, 2008, appropriated \$500,000.00 of Motor Fuel Tax Funds for the improvement of the aforesaid section.

NOW, THEREFORE BE IT RESOLVED BY this County Board of Lake County, Illinois, that a contract be awarded to, Greg Greenhill Construction Company, Inc., Ringwood, Illinois, in accordance with their bid of \$478,576.50 based on estimated quantities and unit prices and that the Purchasing Agent, the County Clerk and the County Engineer of said County be authorized, and they are hereby directed, to enter into a contract with said low bidder for the Bituminous Pavement, where necessary, on various county highways and designated as Section 08-00000-11-GM; and

BE IT FURTHER RESOLVED that there is hereby provided a supplemental appropriation of \$70,000.00 of Motor Fuel Tax funds for this improvement.

BE IT FURTHER RESOLVED that in as much as such estimated quantities are the best approximation that can be determined at this time these quantities may be added to, deducted from or modified from in the final determination of the contract cost in accordance with Chapter 605 of the Illinois Compiled Statutes, Act 5, Section 5-205.2 without further Board action provided the final cost chargeable under the funds appropriated does not exceed the appropriation.

BE IT FURTHER RESOLVED that such award be processed by the County Engineer of Lake County in accordance with the "Agreement of Understanding" between the Illinois Department of Transportation and Lake County dated January 22, 2003.
