## RESOLUTION

WHEREAS, Lake County has 481 voting precincts in 18 townships; and

WHEREAS, a review of said precinct boundaries by the County Clerk's office indicated that boundaries should be adjusted in certain precincts; and

WHEREAS, adjusting the existing boundaries will maintain precincts which are consistent with statutory requirements and County Board policy; and

WHEREAS, it is recommended that voting precincts 54, 230, and 445 be adjusted to conform with recent annexations by the City of Zion; and

WHEREAS, these changes preserve voter privacy and provide for more efficient election administration; and

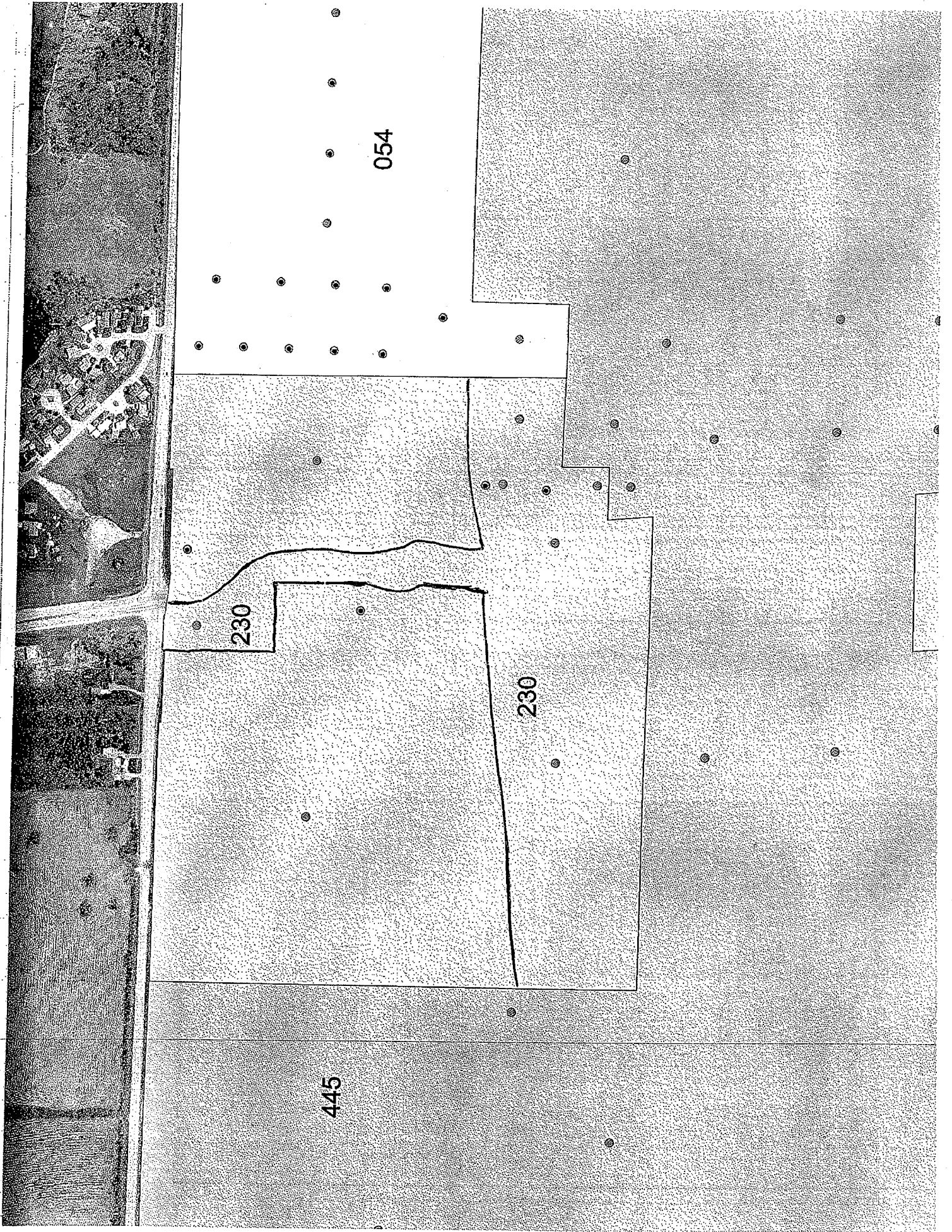
NOW, THEREFORE BE IT RESOLVED, by this County Board of Lake County, Illinois, that the Ordinance Establishing Precinct Boundaries be amended to adjust the existing precinct boundaries of voting precincts 54, 230, and 445, effective immediately, and to describe and name said precincts in accordance with the attachments which are attached hereto and made part hereof this Resolution.

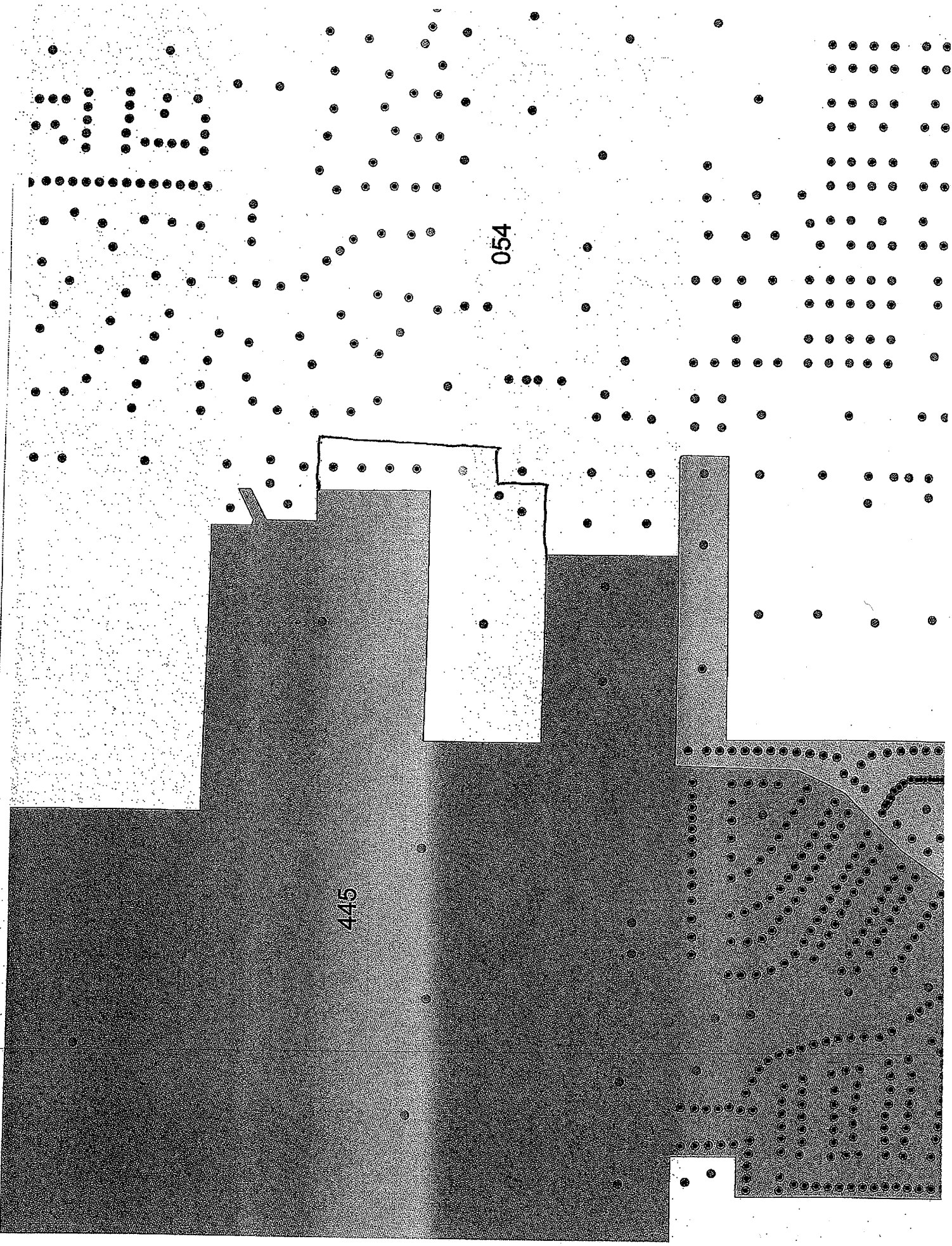
